2. TERMS OF REFERENCE:-

The terms of reference of the Inquiry Commission shall be to:-

- (a) Examine the complete sequence of events relating to the management of the patient at STNM Hospital from admission till referral to the higher centre outside Sikkim;
- (b) Examine and review the clinical assessment, investigations, treatment plan, stabilization measures, monitoring, gynecological care and referral protocol undertaken;
- (c) Suggest corrective measures and accountability, if warranted, based on finding of the inquiry.
- (d) The Commission shall exercise powers conferred under sections 4, 5 and 5A of the Commission of Inquiry Act, 1952.

The Inquiry Commission shall submit its report along with findings and recommendations to the competent authority within fifteen days from the date of issue of this Notification.
