NOTIFICATION

In exercise of powers conferred under sub-section (1) of section 14 of the Bharatiya Nagarik Suraksha Sanhita, 2023, the State Government is hereby pleased to appoint the Block Development Officers, Government of Sikkim as Executive Magistrates to perform the following specific functions within their respective jurisdiction, namely:-

- (1) Swearing or Affirmation of Affidavits under section 333 of the Bharatiya Nagarik Suraksha Sanhita, 2023.
- (2) Issue Scheduled Caste and Scheduled Tribe Certificate.
- (3) Issue Other Backward Class Certificate (Centre/State).
- (4) Issue Income Certificate.
- (5) Issue Property Certificate.
- (6) Issue Employment Card.
- (7) Issue Married/Unmarried Certificate.
- (8) Issue Roof Level Certificate.
- (9) Issue No Landed Property Certificate.
- (10) Issue No Dwelling House Certificate.
- (11) Issue Landed Property Certificate.
- (12) Verification of Birth/Death.
- (13) Hold inquest under section 194(4) of the Bharatiya Nagarik Suraksha Sanhita, 2023.

2. In respect of the aforesaid functions, the Executive Magistrate shall be subject to the control and direction of the District Magistrate and other authority as may be specified under the law.

3. This notification shall come into force at once.

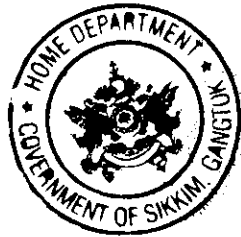
अधिसूचना

- (९) भू-सम्पत्ति नभएको प्रमाणपत्र जारी गर्ने।
- (१०) आवास गृह नभएको प्रमाणपत्र जारी गर्ने।
- (११) भू-सम्पत्ति प्रमाणपत्र जारी गर्ने।
- (१२) जन्म/मृत्युको प्रमाणीकरण।
- (१३) भारतीय नागरिक सुरक्षा संहिता, २०२३-को धारा १९४(४)-अन्तर्गत सोधपुछ गर्ने।
