Consequent upon the establishment of the Directorate of Prosecution in the State of Sikkim in exercise of powers conferred under clause (a) of sub-section (1) of section 20 of the Bharatiya Nagarik Suraksha Sanhita, 2023, vide Notification No. 77/Home/2024 dated 01/10/2024, the State Government notified the Directorate of Prosecution, Establishment Rules, 2025 vide Notification No. 20/Home/2025 dated 07/03/2025 to formulate the establishment and to regulate the method of recruitment in the Directorate of Prosecution.

Now, the State Government, on the recommendation of the Selection Committee constituted under sub-rule (1) of Rule 5 of the Directorate of Prosecution, Establishment Rules, 2025, is hereby pleased to appoint Ms. Jyoti Subba, Advocate, to the post of Director of Prosecution, Directorate of Prosecution, Home Department, Government of Sikkim for a period of 03 (three) years on a contractual basis from the date of her joining.

She shall draw a consolidated pay of ₹1, 15,000/- (Rupees One Lakh Fifteen thousand) per month inclusive of all allowances.

She shall be entitled for drawing TA/DA & Medical facilities as admissible to Group-A Officer of the State Government.
