### NOTIFICATION

464/SKM-LA/2024:- **WHEREAS**, the Governor of the State of Sikkim has, by notification issued under sub-Section (2) of Section 15 of the Representation of the People Act, 1951 (43 of 1951), published in the official Gazette of the State on the 20<sup>th</sup> March, 2024 (Wednesday), been pleased to call upon all of the Assembly Constituencies in the State of Sikkim, to elect members to the Legislative Assembly of the State, in accordance with the provisions of the said Act and of the Rules and Orders made thereunder;

**NOW, THEREFORE**, in pursuance of Sections 30 and 56 of the said Act, the Election Commission of India hereby-

- (A) **appoints**, with respect to the said election from all of the Assembly Constituencies:-
- the 27<sup>th</sup> March, 2024 (Wednesday), as the last date for making nominations;
  - the 28<sup>th</sup> March, 2024 (Thursday), as the date for the scrutiny of nominations;
  - the 30<sup>th</sup> March, 2024 (Saturday), as the last date for the withdrawal of candidatures;
  - the 19<sup>th</sup> April, 2024 (Friday) as the date on which a poll shall, if necessary, be taken; and
  - the 2<sup>nd</sup> June, 2024 (Sunday), as the date before which the election shall be completed; and
