**TERMS & CONDITIONS FOR
EDUCATIONAL/EXPOSURE TOUR FOR THE SIKKIM GOVERNMENT COLLEGE STUDENTS TO
NEW DELHI, AGRA & JAIPUR, 2025-26
(December 2025 - January 2026)**

1. The accommodation for the group of college students and escort faculties is to be provided in not less than "3-star standard hotels" with double sharing rooms.
2. Travel from Gangtok till Delhi-Agra-Jaipur and back and for sightseeing purposes to be done in AC Deluxe buses/Train.
3. The entire group to be provided with 3 meals per day (Veg/Non-veg as per the preference of the students).
4. A minimum of 2-3 guides to be provided for the group.
5. An escort of the travel agency to accompany the group.
6. Tentative travel dates would be during December 2025-January 2026, i.e during the winter vacation of the colleges.
7. The total number of students/faculties will depend on the quotations received for per-head estimates and travel to be done for one batch of students and escort faculties.
8. Registration certificate of the travel agency with the Government of Sikkim to be included.
9. The travel agency must have been registered and operational for a minimum period of 5 years.
10. The travel agency shall ensure the educational importance of the tour and therefore shall support each participant in preparing their individual tour report and educational learning outcome of the tour.
