1. The Rural Development Department, Government of Sikkim, intends for empanelment of manufacturers and establishment of rates for Supply of GSW Tanks including installation at predesignated locations within the State of Sikkim for its various Water Supply Schemes in the State of Sikkim and hereby invites "Expression of Interest (EOI)" from intending Manufacturers with at least 05 years' experience in Manufacturing of GSW Tanks having Registration with DGS&D/ NSIC.

Note

- 1. GSW tanks should be confirming to IS 804 specification and Galvanizing should be as per IS 4759 1996.
- 2. Refer Annexure II, wherein, RDD is issuing 'Expression of Interest" for supply of GSW Tanks to be filled by interested manufacturers for empanelment with the department. RDD will issue order for supply from the empaneled manufacturers as and when required, specifying the requirements. Preferably, supply order will be placed with the manufacturers quoting the lowest price but orders can be placed to other manufacturers at lowest rate depending on procurement volume and delivery time. The empaneled manufacturers will be required to supply the articles at the lowest quoted price in the stipulated time and at the specified place on the basis of the order issued by RDD.
- 3. It may be noted that RDD is not bound to accept the lowest bidder for entire quantity and may split / divide its purchases order among two or more manufacturers. RDD also reserves the right to reject an individual or all the bidder without assigning any reason thereof. RDD gives no guarantee about the definite volume of purchase from any empaneled manufacturers at any given time or throughout the tenure of the empanelment.
- 4. Notice Inviting "Expression of Interest (EOI)" for empanelment including guidelines and Terms & Conditions of empanelment may be downloaded from the tender portal of website 'www.sikkim.gov.in.. However, the documents are nontransferable and can be obtained by the interested parties or their authorized representatives on submission of a written application and on payment of non-refundable fee. Issuance of EOI, however, shall not automatically mean that such party(s) fulfills/meets the qualifying requirements.
- 5. - 18. Bid Should include an affidavit duly notarized that the Company is manufacturer of GI Pipes with valid factory license, PAN No., GSTN/GST Registration Certificate, latest copies of GST3BR, Income Tax return and GST returns of last four years as required by law for such tenders.

Only One Bid Per Bidder

19. Submission or participation by a Bidder for more than once in this Bid will result in the disqualification of all those bids for that contract in which the party is involved.

Category of Panels & validity

20. RDD plans to form panels of Manufacturers/ authorized dealers of Manufacturers for Supply of GI Fittings for a period of two year that may be extended in future at the discretion of RDD.

Order for supply

21. As and when material requirement would arise, RDD may offer supply of GSW Tanks as per the lowest rate accepted from empaneled manufacturers. However, RDD in no way shall be bound to place any order to any or all of the empaneled firms.

Payment Terms

- 22. Terms of reference, payment terms, time schedule and other relevant terms and conditions will be defined for supply of GSW Tanks while awarding the Supply Order. RDD's decision in the matter of award of Supply Order shall be final.
- 23. Advances shall be made only as per Notification No:- GOS/FIN/ADM/02; dated:-24/08/2021 issued by Finance Department, Government of Sikkim.

24. Payment for materials supplied shall be made as per availability of fund. No interest shall be paid in any case.

Delivery of Materials

- 25. The Manufacturer shall express their interest and ability to supply and install the GSW Tanks of below mentioned size to designated locations within the State of Sikkim. The requisite size are as indicated in Annexure II:

- 31. All costs and expenses associated with submission of EOI shall have to be borne by the Applicants and RDD shall have no liability in any manner in this regard.
- 32. The rates quoted for supply of GSW Tanks shall be valid for a period of 12 months. No additional cost shall be considered, unless & until a major variation in rates of Steel & Zinc beyond Rs. 1500/ MT.
- 33. Guarantee/ Warranty shall be furnished by the supplying firm for satisfactory performance and towards any manufacturing defect or bad workmanship in the supplied goods for a period of 12 months from the date of delivery. The rejected materials, if any, shall be removed within 30 days from the date of intimation, and replaced without any extra cost to the Department, by the firm as per the original order terms.
- 34. The EOI shall be submitted in a sealed envelope marked "TENDER DOCUMENTS FOR EMPANELMENT and ESTABLISHMENT OF RATES FOR THE SUPPLY OF JJM STOCK MATERIALS UNDER RDD "against Letter No. 333 & 334/RDD/JJM, Dated:-04/08/2022." and to be addressed to the office at the following address, so as to reach the specified address on or before 24/08/2022 prior to 13.00 Hours. EOI received after the above specified date and time, either by hand or post, shall not be entertained.
- 35. If the envelope is not sealed and marked as above, RDD will assume no responsibility for any misplacement of submittals of the EOI.
- 36. RDD reserves the right to reject any or all EOIs at any stage of the empanelment process, or to annul the process or part of the process and/ or to modify the process or any part thereof at any time, on any justified and genuine grounds, without thereby incurring any liability to the affected Applicants, nor does it have any obligation to inform the Applicants of the ground for the action of RDD.

Inspection & Testing.

37. Manufacturer's test certificate shall have to be produced at the time of supply of GSW Tanks. Each batch of materials supplied must be tested for both Chemical & Mechanical parameters from NABL Accredited laboratory before dispatch from the factory.

Terms & conditions for Vendor Registration / Empanelment as a Supplier

- 38. Manufacturers once empaneled, shall have to promptly reply to all the enquiries, execute orders as per the order terms of RDD and keep the department informed of new products / developments / innovate ideas that shall help reduce the cost and improve quality, reliability etc.
- 39. This document shall be treated as part of a valid contract between Rural Development Department, Government of Sikkim and manufacturers, and adherence to all aspects of fair-trade practices in executing the purchase orders /work orders placed by RDD from time to time during the registration period.
- 40. In case of empaneled manufacturers is found in breach of any terms & conditions of RDD at any stage during the course of supply or warranty period, the legal action as per rules / laws, shall be initiated against the manufacturers and EMD / Security Deposits shall be forfeited by RDD, Govt. of Sikkim, besides debarring and blacklisting the concerned for at least three years, for further dealings in the State of Sikkim.
- 41. The empaneled manufacturers should not assign or sublet the empanelment or any part or it to any to any vendor in any form. Failure to do so shall result in termination of empanelment.
- 42. All empaneled manufacturers are expected to maintain absolute integrity, follow a descent standard of business ethics and do nothing unbecoming of a empaneled manufacturers.
- 43. RDD has all the rights to add / delete / alter any of the items and to amend / add any of the terms and conditions included in the empanelment granted to manufacturers with effect from any date, without assigning any reasons for the same.
