NOTICE INVITING QUOTATIONS

The Rural Development Department invites sealed quotations from registered firms/ authorized agency/ reputed contractors within the **Gram Panchayat Unit** for dismantling of steel bridge parts, RCC decking slab, lifting of bridge parts and other debris damaged by flash flood on "as is where is basis". Details are as under: -

TERM AND CONDITIONS:

- 1. Verification/ site inspection can be conducted in the presence of the Departmental officials.
- 2. The eligible bidder will be allowed to remove the scrap from the premises only after payment of the requisite amount stated in column 3 above. The site should be cleared of all the debris and dismantled materials within ten days of completion of work.
- 3. All machinery, labour, transport and handling charges required for dismantling and removing of scrap and other debris shall be arranged by the firm/ contractor at his cost. The Department takes no responsibility in this regard.
- 4. The work is to be completed within 30 (thirty) days after issue of work order.
- 5. The cost of any unforeseen expenditure shall be borne by the selected firm/contractors. The bidder is responsible for any damage caused to the government property and has to make good the damages.
- 6. The Department shall not be held liable for any untoward incidents while the work is under progress.

- 7. On all matters relating to this quotation call, the decision of the Department shall be final and the same cannot be referred to the court of law.
- 8. The Department reserves the right to accept, reject any or all the quotations submitted without assigning any reasons thereof. For any queries the undersigned can be contacted within the office hours (10 a.m 4.30 p.m) except on Government holidays.
- 9. The Department reserves the right to add/delete/change any of the terms and conditions stipulated in the quotation document. The Department also reserves the right to cancel the work order if the specified terms and conditions are not met by the eligible bidder. Further, the department shall not be held responsible for any loss or damages suffered by the bidder as a result of the cancellation of the work order.
- 10. The successful bidder shall pay the quoted amount <u>specified in column no. 3</u> within 7 days of issue of work order failing which the bid shall be cancelled and security deposit shall be forfeited.

The quotation should contain the following documents:

- 1. The rate quoted by the bidder should be inclusive of dismantling of bridge, RCC decking and lifting of scrap materials and other debris, all complete.
- 2. Quotation document to be signed in each page by the authorized signatory of the bidder
- 3. Detail Name and address with phone no.; e-mail ID of the contact person
- 4. The bidder shall submit security deposit of ₹ 30,000 /as TDR in favour of Director Accounts, RDD, Gangtok. The security deposit will be refunded to the unsuccessful bidder after successful completion of the Bids.
- 5. The Department reserves the right to deduct any expenses, loss/ claims on account of the failure of the bidder to comply with the terms of the contract.
- 6. The security deposit will be forfeited in the event of any failure of the bidder.
- 7. Self-attested copies of certificate of registration, GSTIN, PAN No., Enlistment Certificate to be enclosed.
- 8. Other documents in support of the eligibility of the bidder
- 9. Undertaking along with application stating the rate quoted by the bidder
- 10. Sealed quotations are to be submitted in the office of the undersigned on all working days upto 4.00 p.m by 14 /3/2022 mentioning the bid value. The quotations shall be opened on 15/3/2022 at 2 p.m in the office of the undersigned, where all the bidders may kindly make it convenient to be present.
