GENERAL GUIDELINES

(under Sikkim Co-operative Societies Rules, Rule 3, clause (e))

In addition to the clause (a) to (d), sub-rule 1 of Rule 3 of the Sikkim Co-operative Societies Rules, 1981 (amended up to 2015) the following documents under clause (e), sub-rule 1 of Rule 3 which states "in respect of such documents as may be specified by the Registrar by special or general order" may also be submitted during the time of registration of cooperative society.

1. TDR from SISCO Bank Ltd. of the share collected in the name of the proposed society
2. Resolution copy of preliminary meeting of promoters
3. NOC from the concern area Panchayat/councilor
4. NOC from the house owner where the society wants to run office
5. 2 passport size photograph of each of the members
6. Registration fee of Rs. 1000/- (Bank Receipt from SBS)
7. Sikkim Subject/Certificate of Identification (COI)/RC in case of registration in Urban Areas

In case of employee or student in any Government Institution or companies NOC from concern employer/head of educational institutes respectively is required.

In exercise of the powers conferred by section 55 of the Sikkim Cooperative Societies Act, 1978, the State Government hereby makes the following amendments to Notification No.1/Coop., dated 11/5/1993 regarding norms for release of financial assistance to the Cooperative Societies, namely:
