2. The rate of Maintenance Allowance for each course for an academic session shall be as prescribed by the concerned Ministry.
3. The new rate of scholarship shall come into effect from the academic session 2021-22.
4. The academic fee reimbursable by each student shall be as prescribed at column 3 subject to maximum or actuals whichever is less.
5. The rate of scholarship for students studying at empanelled Colleges enrolled prior to this academic session shall continue as per old rate till they complete their enrolled courses.
6. This notification supersedes all other Office Orders issued in this regard by the Department.
