### 1. Other terms and conditions:

- a) The post is purely on temporary basis for a period of one year and renewable every year on the basis of performance of the candidate.
- b) Applicant should possess Sikkim Subject Certificate/Certificate of Identification issued by the competent authority of the Government of Sikkim.
- c) Candidate should have valid local employment card or NOC in case of in-service candidates.
- d) Age Limit: candidate should have attained the age of 21years but should not have exceeded 40years at the time of interview.
- e) No TA/DA shall be admissible for appearing in the interview.
- f) Prescribed application form is available in the office of the undersigned and also uploaded in the Board's website. Candidate desirous of applying may submit the application and requisite document along with Demand Draft of Rs 200/-(Rupees two hundred only) in the name of Member Secretary, SPCB-Sikkim payable at Deorali.

- h) Candidates against whom there is/are adverse report regarding character & antecedents, moral turpitudes are not eligible to apply for the post.
- i) Persons terminated on disciplinary grounds are not eligible.
- j) Selected candidate requires to furnish fitness certificate at the time of appointment.

Selection of the candidate shall be done on the basis of interview to be conducted by an Interview committee. Decision of the Interview committee shall be final and binding.
