2.	Blazer (Dark Grey with Monogram)	1	1 year	For winter. 2 sets in first year.
3.	Black Terri wool Pants	1	1 year	For winter. 2 sets in first year
4.	Shirt Pure White	2	1 year	
5.	Shoes Black	2 pairs	1 year	
6.	Camouflage Tactical Cress (in 2 pieces)	3	2 years	For Armed Personnel deployed for escort and outer circle duty of protected person.
7.	Beret Cap (with Sikkim Police Logo Badge)	3	2 years	
8.	Hat FS (with Sikkim Police Logo Badge)	1	1 year	

9.	Combat Boots Black (International SWAT Team Quality)	2 pairs	4 years	In lieu of duty Combat Boots
10.	Camouflage Combat half Jacket with magazine pouches	1	1 year	For Armed Personnel deployed for escort and outer circle duty of protected person.
11.	Security Metal Badge	1	2 years	To be put on the right chest above name plate
12.	Winter Jacket	1	4 years	
13.	Operation head mask black	1	1 year	
14.	Firing Gloves	2 pairs	1 year	

The officers and personnel deployed for the security of HCM and other protected persons will be entitled to the uniform articles as above in addition to and in replacement as the case may be of the regular uniform articles prescribed in Notification No. 40/Home/2019 dated 16.04.2019.
