**DECLARATION UNDER SECTION 19 OF RIGHT TO FAIR COMPENSATION AND
TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT, 2013
(ACT 30 OF 2013).**

Whereas, vide Preliminary Notification No.24/LR&DMD/ACQ/GOS/dated 08/12/2023 and Gazette Notification No.508 dated 08/12/2023, it was notified under section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Act 30 of 2013) that the land described in the Schedule hereto thereafter referred to as the said land were required or likely to be required for the purpose of New alignment and muck dumping on Mangan-Chungthang Road by Border Road Organisation 107 RCC (GREF), (MoD) Government of India in the revenue blocks of Shipgyer, Toong and Naga-Namgor, North Sikkim based on the field report submitted by Sub-Divisional Office, Chungthang.

And whereas, preparation of the mandated Rehabilitation and Resettlement scheme shall not be applicable because there is no displacement of family/families due to the proposed acquisition.

And whereas, as per Section 19 (1) of Right to fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the appropriate Government is satisfied that the said lands are required for public purpose.

Now, therefore, it is hereby declared under the provision of Section 19(2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the said lands are required for the public purpose, namely for the purpose of new alignment of Mangan –Chungthang road in the blocks of Shipgyer, Toong and Naga-Namgor, North Sikkim.
