NOTIFICATION

No.100/SKM-LA/02/2024:- **WHEREAS**, the seat of Shri P. S. Tamang in the Legislative Assembly of the State of Sikkim, elected from **7-Soreng-Chakung Assembly Constituency**, has become vacant on **14th June, 2024** by reason of his resignation; and

2. **WHEREAS**, a bye-election is to be held for the purpose of filling the vacancy so caused;

3. **NOW, THEREFORE**, in pursuance of Sub-section (1) of Section 150, and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby –

(A) **calls upon** the said **7-Soreng-Chakung Assembly Constituency** in the State of Sikkim, to elect, before the **25th November, 2024 (Monday)** and in accordance with the provisions of the said Act and of the Rules and Orders made thereunder, a person for the purpose of filling the said vacancy in the said Legislative Assembly of the State and;

(B) **appoints**, with respect to the said election, -

- (a) the **25th October, 2024 (Friday)**, as the last date for making nominations;
- (b) the **28th October, 2024 (Monday)**, as the date for the scrutiny of nominations;
- (c) the **30th October, 2024 (Wednesday)**, as the last date for the withdrawal of candidatures;
- (d) the **13th November, 2024 (Wednesday)**, as the date on which a poll shall, if necessary, be taken; and
- (e) the **25th November, 2024 (Monday)**, as the date before which the election shall be completed; and

(C) **fixes the hours** from **07:00 A.M. to 05:00 P.M.**, as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.
