The following Act passed by the Sikkim Legislative Assembly and having received the assent of the Governor on 18th day of March, 2023 is hereby published for general information:-

THE SIKKIM APPROPRIATION (VOTE ON ACCOUNT)

(ACT NO. 02 OF 2023)

ACT

to provide for the withdrawal of certain further sums from and out of the Consolidated Fund of the State of Sikkim for the Services of a part of the Financial Year 2023-24.

BE it enacted by the Legislature of Sikkim in the Seventy-fourth Year of the Republic of India as follows: -

Short title

1 This Act may be called the Sikkim Appropriation (Vote on Account) Act, 2023.

Issue of Rs 2604,92,75,000/out of the Consolidated Fund of the State of Sikkim for the Financial Year 2023-24. 2 From and out of the Consolidated Fund of the State of Sikkim, there may be withdrawn sums not exceeding those specified in column 5 of the Schedule amounting in aggregate to the sum of rupees two thousand six hundred four crore ninety two lakh seventy five thousand only towards defraying the several charges which will come in course for payment during the Financial Year 2023-24, in respect of the services and purposes specified in column 2 of the Schedule.

Appropriation

3 The sum authorised to be withdrawn from and out of the Consolidated Fund of the State of Sikkim by this Act shall be appropriated for the services and purposes specified in the Schedule
