#### NOTIFICATION

The Ministry of the Agriculture & Farmers Welfare, Department of Agriculture, Co-operation & Farmers Welfare, Government of India has launched a new pan India Central Sector Scheme, "Financing Facility under Agriculture Infrastructure Fund" for providing mediumlong term debt financing facility for investment in viable projects for post-harvest management infrastructure and community farming assets through interest subvention and financial support.

Accordingly, in order to ensure real-time monitoring and effective feed-back about the implementation of the Scheme, the Ministry desires creation of a State Level Monitoring Committee (SLMC) and a District Level Monitoring Committee (DLMC).

- 3. It will also examine the proposal and recommend to SLMC for consideration.
- 4. DLMC will set targets in consultation with SLMC as per OOMF format and monitor
- the progress closely with the support of PMU. 5. DLMC will maintain the dashboard in collaboration with PMU.
