2. Terms of Reference:

The terms of reference of the State Committee shall be as under namely:

- (1) The Committee shall discharge such functions as specified in the Third Schedule as may be necessary to prevent dam failure related to disasters under this Act as per Guidelines, standards and other directions on dam safety issued by the Authority.
- (2) The Committee shall meet as prescribed in the Dam Safety Act, 2021.
3. The Power Department, Government of Sikkim shall be the Nodal Department for implementation and administration of the Dam Safety Act, 2021 (No. 41 of 2021) in the State of Sikkim.
