### SDM (HQ) & SDPO (Namchi) visit monasteries for sensitization

Namchi, July 13: SDM (HQ) Mr. Chiran Rizal along with SDPO (Namchi) Mr. Kessang D. Bhutia visited Ngadak Gumpa, Upper Ghurpisey Gumpa, Alley Gumpa and Tamang Gumpa, Boomtar today to sensitize the management about the spread of Covid-19 and the necessary precautionary measures to be taken. The Incharges of the monasteries were instructed to ensure that Covid appropriate behaviour is strictly followed. There were asked to refrain from conducting puja and avoid gathering till further orders.

They were advised to identify a dedicated vehicle and person to be engaged in visiting markets and bringing essential commodities, to minimise contact with students staying in the Gumpa. They were also requested to ensure wearing masks at all times.

The SDM (HQ) also instructed Gumpa Management of Bermiok Gumpa, Namphing Temi and Nagi Gumpa to follow COVID-19 protocol strictly.

### Meeting to discuss JJM for left out areas

Namchi, July 09: A meeting to discuss Jal Jeevan Mission (JJM) for left out areas of Yangang and Temi Namphing Constituency was held at DAC, Namchi today. DC (South) Mr. M. Bharani Kumar chaired the meeting. Present amongst others were, ADC (Dev, Namchi) Dr. Chandra Prakash Rai, ADC (Dev, Ravangla) Mr. Sunil Mothey alongside other officials.

The meeting deliberated regarding the various proposals under Yangang BAC and Temi BAC, such as Augmentation, Renovation and Retrofitting of RWSS of mega projects connecting from various Gram Panchayat Units.

It maybe mentioned that two projects, namely, that of Rural Water Supply Scheme at Yangang and its adjoining villages in South Sikkim and RWSS at Namphing and its surrounding area under Temi Namphing Constituency, which were sanctioned under National Rural Drinking Water Programme (NRDWP) have been proposed to be covered through JJM.

The officials discussed the areas that need works on laying pipelines and other important aspects in providing drinking water. They also emphasized that the stakeholders should ensure that the projects under JJM should be completed in a time bound manner and to provide long-term sustainability of water supply system. It was also decided that functional tap connection will be provided to schools, health and wellness centers and other community buildings as prescribed in the mission.

### MLA visits construction sites at Soreng-Chakung constituency

**Soreng, July 08:** MLA(Soreng-Chakung), Mr. Aditya Golay visited the construction sites of the ongoing and upcoming projects currently under the constituency.

The MLA and team visited the under-construction site of Engineering Complex near Don Bosco School Guest house, Malbasey. He inspected and enquired about the on-going construction activities and reviewed the progress. This was followed by a meeting at the Rural Development Department premises at Chota Samdung regarding the upcoming Model Residential School.

An in-depth presentation about the structure, facilities and the features about the school was given by the Architect, Design and Concept Department. He said that the school will be constructed in three respective zones namely-Administrative, Residential and Sports zones. He added that the school will have a State-of-the-Art facilities and features, such as an in-house digital library, wherein the students can have access to online information. The construction of the school will be done in such a way that it will provide wase and convenience for all students, including differently-abled students, he concluded.

Panchayat President, Mr. D.K. Subba said that a massive project like this will bring prosperity to the area along with financial stability for the locals. He then laid down some of the grievances of the local public. One of the main issues discussed was the compensation that is to be given to the probable land owners. Better prospects and future growth are inevitable with the construction of the Model School, he said.

MLA (Soreng- Chakung) stated that such Model Schools will be constructed in one of the Zillas in each district. He reiterated that one of the main reasons for constructing the school is to provide quality education facilities and adequate knowledge to the students, especially to those having weaker financial status. He expressed his gratitude to Minister of Education, Mr. Kunga Nima Lepcha for

approving and accepting the request to construct the project in the area. He mentioned that the importance of constructing school on the outskirts of the main town is to avoid distraction and disturbance. He stated that all the owners would be compensated fairly as per the current Government land rates. He stated that employment will be provided to those local people, who are capable and meet the required norms. He urged the local community to give their full support and contribution in building a better future.

The MLA and team also visited the site of the meeting at Chakung Public Ground. The concerned department officials along with the Contractors, the Engineers and the Consultancy Agency gave an over-view about the site plan and demonstration of the new project under the name 'Subash Chandra Bose Centre of Excellence'. Mr. Golay also enquired and discussed about the facilities that are to be provided along with the required infrastructure for better learning by the students.

### Field Monitoring of SGAY conducted

Namchi, July 03: Field Monitoring of Sikkim Garib Awas Yojna (SGAY) was conducted for Sumbuk Block under the leadership of Additional Political Secretary (South) to Chief Minister Ms. Anjeeta Rajalim, accompanied by ADC Dev. Namchi, BDO Sumbuk, concerned Panchyat members, President, CLC, NGOs, officials from ADC, Dev./ BAC, Sumbuk, Project Manager / Incharge/ Engineers, MTL Pvt. Ltd Singtam and beneficiaries.

The programme started with a briefing on background of SGAY scheme by Project Manager, followed by an interactive session amongst beneficiaries, Project Company, Panchyat members and the concerned departmental officials. On the two-day programme, 4 GPUs, Sumbuk- Kartikey, Lungchok-Kamarey, Sadam-Suntaley and Malli Dara-Paiyong were covered. Turuk-Ramabong GPU couldn't be covered as it falls under the containment zone area.

It may be mentioned here that grievances and problems faced by the beneficiaries were addressed by the monitoring team and provided assurance as well as support to various issues related to SGAY to complete their houses in the stipulated time frame. After the programme, the team visited the construction site. APS assured all possible help to the beneficiaries and asked them for their cooperation. The project company representatives were directed to start the construction works within a week, without compromising on the quality and quantity of the building materials.



### District Collector (South) inspects various damaged areas

Namchi, July 08: The District Collector (South) Mr. M. Bharani conducted inspection of damages at Salghari, Upper and Lower Wok and Samatar. He was accompanied by Zilla Adhyakshya (South), Asst. Engineer (Roads & Bridges Department), DPO (Disaster Management), Panchayats and other public representatives.

The team inspected Ringzi Khola near Kholaghari where damage to public property was observed. The team also visited, Upper and Lower Wok road, which is under the Roads Department. It was seen that formation of the both the roads has been washed out thereby cutting off rural connectivity. Damage to Foot over bridge was also seen.

The public reported about slowness in construction of PMGSY Road connecting Sikkip-Upper Omchu (8.5 kms). The status report of the same shall be sought from DE PMGSY. The team inspected few landslides that had occurred below the dwelling houses as well as Samatar Suspension Bridge. It was observed that one end of bridge was badly damaged and needed repair works.

The HT Line belonging to the Power Department required immediate protective works. The same would be informed to the Power Department.

# Minister L.N. Sharma conducts meeting with department officials

**Gangtok, July 09:** Minister for Agriculture and Horticulture Mr. L.N. Sharma convened a meeting with the department officials on the production of Large Cardamom, its incentive Schemes and post production activities, at his official chamber at Tashiling Secretariat, today.

The meeting was attended by Advisor, Information and Public Relations Department Mr. Birendra Tamling, Secretary Horticulture Department, Mr. M.T. Sherpa, Additional Director (Spices section) Horticulture Mr. B.L. Dahal, Scientists Grade 'C' - Spices Board Dr. T.N. Deka, Deputy Director Mr. M.S. Ramalingam and concerned officials.

The Minister stressed on creating massive awareness on the Production Incentive Scheme and revised financial incentives initiated by the state government to encourage farming community and upscale the rural economy. It may be mentioned here that the state government has recently revised financial incentive per Kilogram of Cardamom from ₹20 to ₹100 along with other focused crops.

He directed the department to constitute a committee in order to ensure smooth conduct of activities pertaining to cultivation of large cardamom, production, disease management and marketing along with other spice varieties. He advised for setting up of production unit of Pseudomonas, a bio agent, in each district of Sikkim for disease management in Large Cardamom. He also suggested that packaging and marketing of large cardamom in tourist destinations besides usual marketing points would be beneficial.

He asked the deptt. to work in active coordination with the Spices Board, Government of India in execution of spices related activities, including the time bound distribution of cardamom seedlings and other related works.

The meeting also discussed about awarding dealer license to FPOs and to organize auction of large cardamom by SIMFED in support of Spices Board and the Horticulture Department.

Thereafter, the Minister called a separate meeting with Sikkim State Co-operative Supply and Marketing Federation Ltd. (SIMFED), which was attended by Managing Director Mr. Bhasker Basnett, Chief General Manager Mr. Deoraj Dewan, General Managers Mr. Yogesh Gurung and Mr. Kailash Rai and other officials.

The Minister threw light on the initiation of financial incentives for new varieties of crops and vegetables and underlined the need to work tirelessly and strengthen field exercise for the welfare of the farmers. He also advised to promote packaging and branding of agriculture and horticulture produce and ensure benefit to the farmers/ vegetable growers at large.

It may be noted that the state government has accorded approval to provide financial incentives for new varieties of vegetables that includes ₹5 per kilogram of Cabbage, ₹7/kg of Cauliflower, ₹8/kg of Green Pea, ₹20/kg of Dalley Khorsani,₹7/ kg of Radish,₹7/kg of Carrot and ₹20/ kg of Kiwi, which need to be sold through organised sectors.

He stated that the farmers need to report the quantity of production at their nearby VLW Centre or identified cooperatives/ FPOs/SIMFED/ Denzong Agriculture Cooperative Society/SHG/ departmental field functionaries, which would be followed by field verification by the concerned authority. Gangtok, July 13: The Minister process of marketing of identified varieties will be executed through organized sector, which will be a an authenticated medium to provide the incentives to the farmers, even the marginalized farmers will be benefited for selling minimum quantity of production, leaving no floor benchmark in terms of quantity and no limitation in numbers of farmers beneficiaries, he added. He also urged FPOs to work proactively and concerned departments, DCs, ADCs, BDOs, Panchayats, field functionaries to be actively involved in successful implementation of the programme.

Further he spoke about the mechanism to create massive awareness about the newly initiated incentive, for increasing productivity in the farming community. He informed that the state government is putting all endeavours to strengthen rural economy and based on data collected, every year, people spend around 100 Crore in importing poultry, 68 Crore in Piggery and 43 Crore in fish. This amount could be circulated amongst the farming community of Sikkim by tapping the resources if our farmers get

farming sectors, he said. Secretary Horticulture, Mr. M.T. Sherpa informed that

in view of controlling undue advantage of Hoarding and Profiteering, there is ceiling in receiving incentives of Rs. 30,000/- per crop and Rs.1 lakh against selling of all varieties. The incentives will be provided twice a year, he said.

Secretary AH&VS, Dr. Sangay D. Bhutia outlined details on financial incentives for Piggery farming. He elaborated framed criteria in details and mentioned that the weight of each pig should be of 50 kg at minimum to be entitled for the financial incentives of Rs 15,000/- at the rate of Rs. 5000/per pig. The State Government has already allocated Rs 3 crore and the amount is adequate to cover at least 1800 beneficiaries in the initial phase, while there is no limitation in number of beneficiaries against fulfilling the criteria. He mentioned that there is a three-tier committee at State, District and Block Level, involving Panchayats, veterinary officers, field functionaries and all concerned, for the implementation of the programme.
