Review Meeting on COVID-19

Gangtok, July 15: Chief Minister Mr. Prem Singh Tamang chaired a high-level meeting to review the COVID-19 situation in the State and to deliberate on the way ahead at Samman Bhawan, today.

The meeting had the presence and participation of Ministers, DGP, Additional Chief Secretaries, HoDs, senior Government officials, District Collectors, Chief Medical Officers, Health Department officials, ADCs (Development), and officers of the Covid-19 Management Group.

The Chief Minister issued strict directives to the District SPs, Collectors, ADC Development and BDOs to ensure that strict measures are adopted to contain the further spread of Covid-19. He called for the need to review the containment measures. He laid emphasis on home quarantine, even for people who move out of their ward or village. the District He urged Administration to review the paid quarantine facilities for people entering the State through the inter-state borders. He urged the Health Department officials to augment mass testing.

Department for successful implementation of the vaccination programme and called for additional measures to ensure 100% coverage.

The Chief Minister directed the Tourism Department to facilitate smooth movement of tourists into the State, duly ensuring that all safety measures are strictly followed. Likewise, Labour Department and Police Department were directed to strictly monitor the movement of

Delta Variant confirmed in Sikkim

Gangtok, July 19: Out of 98 COVID-19 positive samples from Sikkim sent for Genome Sequencing, 97 samples have been detected as Delta Variant of COVID-19. This information was shared by Minister for Health, Dr. M.K. Sharma in an urgent press conference convened at Tashiling Secretariat, today.

The Minister was joined by DG-cum-Secretary, Health, Dr. Pempa T. Bhutia.

confirmed through a CT scan. He stressed that even minor symptoms of COVID-19 should immediately be reported to the nearest health facility.

He shared that the consistent rise in the positivity rate in the State led the authorities to send the samples for Genome

Namchi, July 18: The Chief Minister Mr. Prem Singh Tamang visited Rolu Mandir and offered his prayers for the well-being of Sikkim and Sikkimese people.

In addition, the Principal Chief Engineer, Chief Engineer (Tourism) and other officials were also in attendance and delivered a presentation regarding the forthcoming redevelopment and construction of the Rolu Complex, Minister for Tourism, Mr. B.S. Pant was also present.

He also shared that the Delta Variant has a tendency to escape RTPCR negative report, and has to be

Dr. Sharma said that the State Government will monitor the situation very closely and will intensify testing, tracing, treatment, vaccination, emphasis on Covid appropriate behaviour, and strict implementation of prescribed guidelines for containment areas. Milching Cows distributed under NEC Fund

Gyalshing, July 17: Distribution of Milching Cows in to Supplement Farmer Income Under NEC Fund for the year 2020-21 was held at Chongrang BAC premises under Yuksom Tashiding Constituency, today.

The programme was graced by the Minister for Agriculture, Mr. L. N. Sharma as the chief guest in special presence of the Deputy Speakercum-Area MLA Mr. Sangey Lepcha. The programme was organized by the Office of the District Collector West in coordination with the Animal Husbandry and Veterinary Services Department. It was followed by inspection of various Milk Collection Centres and Departmental infrastructures under Yuksom Tashiding.

The Minister handed over twenty cows of Jersey and Sahiwal Jersey Cross breed to the identified beneficiaries and began the distribution of 150 Cows under Chongrang Block.

The distribution programme also had the presence of Advisor Ecclesiastical Department Mr. R.S. Bhutia, Chairman Transport Department, Additional Political Secretary to CM (West): Secretary AH&VS: District Collector (West); Additional Director Feed and Fodder (HQ); Additional Director (West); Joint Director Agriculture; Joint Director Horticulture, Dy. General Manager (SMU), SDM/ BDO Yuksom, BDO Chongrang, departmental officials and panchayats.

He elaborated the farmers friendly policies and programmes and stated that all should be well aware of newly framed policies to sensitize, motivate and guide the farming community.

Correlating the distribution of Milching Cows and financial incentives of ₹8, he said that the Dairy farming has become a primary source of livelihood in rural areas and the production of Milk has been increasing consistently and touching daily production of around 60,000 Litres per day in organised sector because of growing interest and determination amongst the dairy farmers.

He informed that the Nine Milk Collection Centres of Chongrang are being presented ₹5 lakh each for the establishment of Milk Producers Cooperative Society (MPCS), which he handed over to all concerned. He urged all committee members for proper utilisation of the provided fund with utmost sincerity to ensure quality work in construction of the MPCS.

He also threw light on the mandatory guidelines to get the registration of the identified land for MPCS in the initial stage.

He informed that marketing shall be done through registered institutions namely, FPOs, SIMFED, Denzong Agriculture Cooperative Society or in facilitation of concerned VLWs, Field Assistants and designated officials.

Deputy Speaker Mr. Sangey Lepcha, mentioned that the milching cows were distributed for socio-economic upliftment of the Chongrang cluster. He also urged every beneficiary to attend training and obtain technical skills in dairy farming in order to derive maximum benefit out of the available facilities.

Secretary AH&VS Department, Dr Sangey D. Bhutia urged beneficiaries to take optimum benefit of availed facilities and informed that the department would provide training to the beneficiaries.

District Collector (West), Mr. Karma R. Bonpo marked the distribution of Milching Cows as one of the significant initiatives for the development of Chongrang block. He advised the beneficiaries to consider the token as a component for sustainable development and not as short-term benefits, so that the block can uplifted in socioeconomic dimension.

The Minister led field inspection in the Yuksom Tashiding Constituency and firstly visited Milk Collection Centre at Gerethang, followed by Labing VLW Centre. At Labing Milk Producers Cooperative Society, Mr. Sharma handed over Provisional Sanction Intimation of ₹5 Lakh to the MPCS Committee Members/Land Donor.

At Mangtabong Milk Collection Centre, the Minister handed over Sanctioned intimation of 5 Lakhs each to both Mangtabong and Mangsabong MCC.

This was followed by visit at proposed construction site of Khyongtey MPCS under Yuksom Dubdi GPU.

The team visited at Tsong Dubdi MPCS and had a brief session, wherein the demand for transportation facilities was amicably resolved to ensure delivery of collected milk at Jorethang Milk Union via Pelling.

Thereafter, at 13th Mile / Thingling Khechuperi GPU, he formed a committee for the registration of land of VLW Centre located at Thingling. Mr. Sharma also handed over a Sanctioned document of ₹5 lakh each to both Thingling and Darapthang Milk Collection Centre. Upon knowing that the centre procures around three hundred litres of Milk at Lamathang Milk Collection Centre, he assured to establish a Society House at the locality in view of dairy potential.

The inspection concluded with the visit at Melli Village Milk Collection Centre under Melli Aching GPU and Boom MPCS under Rimbi Timbrong GPU.

Co-ordination meeting of District Task Force conducted

Namchi, July 16: A co-ordination meeting of District Task Force was conducted at DAC Conference Hall, today. The meeting was chaired by DC (South) Mr. M Bharani Kumar, ADC (South) Mr. Satyan Pradhan, ADC(DEV) Dr. C.P.
