Gangtok, September 13:Chief Minister Mr. Prem Singh Tamang inaugurated the first house constructed under Sikkim Garib Awas Yojana (SGAY) at Nandok, Syari constituency and handed it over to the beneficiary, a 65-year-old Mr. Athup Lepcha of Nandok.

He was accompanied by Minister cum Area MLA, Mr. Kunga Nima Lepcha, Cabinet Ministers Mr. B.S. Panth and Mr. Bhim Hang Limboo, MLAs Mr. G.T. Dhungel and Mr. Em Prasad Sharma, Advisor Mr. Tenzing Lamtha, Principal Secretary, RDD, Mr. C.S Rao, senior officers of RDD, ADC (Development) Gangtok, BDO Nandok and officials.

He congratulated Mr. Athup Lepcha for being the first beneficiary under the housing scheme. He thanked and congratulated the Rural Development Department for completing the houses under the scheme in a record time of 11



months, despite the pandemic and other hurdles. He informed that the first phase of Sikkim Garib Awas Yojana will be completed by March 2022.

The Chief Minister also announced to provide house upgradation of ₹20,000/- each before Dusshera festival to 400 beneficiaries in each constituency

in the name of the female member of the house. Along with this, 100 beneficiaries in each constituency will also be provided with GCI sheets. He maintained that since the Government is constructing homes for the people, both rural and urban, the practice of distributing GCI sheets, will gradually be discontinued.

B. GENERAL CONDITIONS

NOTICE

This is for information of all concerned that, the Ministry of Environment, Forest and Climate Change, Government of India has notified the revised guidelines for Idol Immersion. Idols made up of only natural, biodegradable, eco-friendly raw materials without any toxic, inorganic raw materials such as traditional virtuous clay and mud should be encouraged, allowed & promoted and dried flower components, straw for making ornaments of idols and natural resins or trees may be used as a shining material for making idols attractive.

Use of single use plastic and thermocol materials and use of toxic and non-biodegradable chemical dyes/ oil paints for painting idols shall be strictly prohibited. Enamel and synthetic dye based paints on idols are to be discouraged.

Low height and eco friendly idols (made with natural clay idols stuffed with eco-friendly food materials such as corn, spinach, wheat and vegetable powder), idols decorated with bio- degradable, organic colours and non-toxic should be used for offering in poojas to avoid impact on the environment. For the protection of the environment the Pooja Organising Committees shall procure eco-friendly idols only from the respective ULBs registered or authorized craftsman or artisans. Use of clean multiuse metallic or glass utensils is ideal choice and only biodegradable plates may be used for Prasad distribution and other purpose.

Large scale idol manufactures (atleast involved in making more than 100 idols in a day) shall obtain registration from the concerned ULBs. Pooja Organising Committees should seek prior permission from concerned ULB as the case may be providing management plan and the required provisions for ensuring safe idol immersion during festival season at least one month in advance for making necessary arrangements in consultation with the concerned departments.

Minister L. N. Sharma represents Sikkim in virtual conference of CM of states

Gangtok, September 07: Minister for Agriculture and Horticulture Deptts, Mr. L. N. Sharma represented Sikkim in a virtual conference of the Chief Ministers of States called by the Union Minister, Agriculture and Farmers Welfare, Government of India, Mr. Narendra Singh Tomar, today.

The video conference was also joined by the Commissioner-cum-Secretary, Horticulture Department Mrs. Yashoda Bhandari and Secretary Agriculture Department Mr. Rinzing C. Bhutia. Various subjects including the recent modification in initiatives of the Agriculture Infrastructure Fund (AIF) and opportunities for the states were discussed in detail.

The meeting also contemplated the need to make India self-sufficient in edible oils and pulses, the role of states and credit availability. Mr. L. N Sharma spoke on the agenda of AIF and informed that the departments of Agriculture and Horticulture are making efforts to dovetail the AIF scheme with other schemes like MOVCD-NER, HMNEH etc. for the creation of functional infrastructure for post-harvest activities. In Sikkim, more than 10,000 farmers have been benefited and more farmers are being enrolled, he added.

He proposed for the establishment of an export-oriented, industry-empowered Organic Food Park cum Free Trade Warehousing Zone (SEZ-FTWZ), offering common third party logistics and supply chain infrastructure organics-only

processing, handling and warehousing facilities, which will serve as an attraction for private players into organics in Sikkim and the other NE States. He stressed the necessity of the construction of water harvesting structures for secondary and micro storage and enhancing the potential of traditional water bodies at the village level and underlined the difficult topographical challenges of Sikkim and requested the Union Minister to provide subsidies on organic manure to the farmers of Sikkim as a substitute for chemical fertiliser.

Earlier, Union Minister, Mr. Narendra Singh Tomar in his opening remarks, acknowledged the efforts of the State Government in the implementation of various schemes of Central Government and further urged to ensure a better and bright future of farmers. He also advised connecting agriculture with advanced science and technology, which will be influential in doubling the farmer's income and productivity.

Union Minister for Commerce and Industry, Food, Public Distribution and Consumer Affairs and Textiles Mr. Piyush Goyal correlated the indispensable need of agriculture with food security and consumers requirements.

The programme had the participation of the Chief Minister of various states including, Arunachal Pradesh, Manipur, Meghalaya along with the Agriculture Ministers from different states.

Food Safety Training and Certification programme held

Gangtok, September 07: A two-day Food Safety Training and Certification programme from September 5 to 7 was conducted at the Conference Hall of Sikkim Milk Union, Tadong, today. The programme was held under the direction and guidance of Additional Chief Secretary-cum-Food Safety Commissioner Mr. K. Sreenivasulu, Health and Family Welfare Department in collaboration with Deputy Director CISR-CFTRI and empanelled Training Partner with Food Safety and Standards

Authority of India Mr. Jasjit Singh Sandhu.

The main objective of the programme was to sensitize food handlers involved in manufacturing of Dairy Products to ensure safe, wholesome and sustainable food to general public at large.

30 participants from Dairy Industry of all the districts attended the programme. MD Sikkim Milk Union Dr. A.B. Karki chaired the programme along with Joint GM, Mr. Vishal Tiwari.

PMMVY Saptah organised

Gangtok, September 07: The Social, Justice and Welfare Department organised Pradhan Mantri Matru Vandhana Yojana (PMMVY) Saptah with the Zilla and Panchayat members and Councillors of East District at the Conference Hall of East District Zilla Panchayat, Gangtok, today.

Zilla Adhakshya (East) Mr. Samsher Bokhim was present as the chief guest.

The objective of programme was to sensitise the Panchayat members and Councillors about the nutrition, health and hygiene of pregnant, lactating women and the PMMVY scheme.

DPO (East) Mr. Samdup Bhutia emphasized on the

significance of the programme and also mentioned the importance of a nutritious diet for a mother and a child.

Deputy Mayor (GMC) Mrs. Tshering Palden reiterated the importance of a healthy mother and child leading towards a developed society.

Mr. Ragul K, talked about the importance of the maternity benefits programme under the Ministry of Women and Child Development, Government of India.

Later, Director (ICDS), SJ&WDepartment Mrs. Normit Lepcha gave a presentation on the PMMVY scheme and also informed about its objectives.

Skill Development Training programme on Trout and Carp Farming

Gangtok, September 13: The three-day Skill Development Training programme on Trout and Carp Farming, commenced at Atal Incubation Centre (AIC)-SMUTBI, Majhitar, today.

PD-cum-Secretary, Animal Husbandry and Veterinary Services Department, Dr. Sangey D Bhutia, graced the inaugural session as the chief guest in the presence of Director Incharge, Composite Regional Centre under DEPwDs, Ministry of Social Justice and Empowerment, Government of India, Moirangthem Irish, Director, Directorate of Fisheries, Mr. N. Jaswant.

Over 30 fish farmers and educated youths attended the Entrepreneurship Development Training on fish farming. The programme is being organised in joint collaboration with the Directorate of Fisheries, Government of Sikkim and AIC-SMUTBI, Majhitar, East and

supported by the National Fisheries Development Board, Hyderabad.

Dr Sangey D Bhutia urged the trainees to imbibe the inputs from the training session and bring in practice for the augmentation in fish production in the state. He also touched upon the current scenario of traditional fish farming practice and outlined the need for transformation in the fisheries sector with the adoption of newly emerged advanced methods extensively to enhance productivity and farmers income. He encouraged the fish farmers for an increase in production level and added that the augmentation in farming practices will certainly lead to reduce the current ratio of imports. He advised the trainees and fish farming aspirants to visit the newly launched e-portal i.e. <https://pmmsy.sikkim.gov.in/> and take benefits of various provisions under Pradhan Mantri Matsya

Sampada Yojana, through online mode.

Director, Mr. N Jaswant, gave an overview of the training programme and anticipated making a fruitful and output-oriented session for the growth of the fisheries sector. He informed that the trainees will be imparted useful knowledge in terms of an overview of the fisheries sector, current scenario and future perspectives, different farming techniques for intensive and integrated farming, value addition, various provisions in PMMSY for entrepreneurship development etc.

CEO, AIC, SMUTBI Dr. Tej Chingtham presented the role of AIC in skill development and entrepreneurship.

It may be mentioned here that the Persons with Disabilities will also be incorporated and encouraged towards fisheries farming to earn their livelihood under the guidance of CRC/Sikkim.

Su-Swastha Yojana to roll out from 1st October

Gangtok, September 08: Su-Swastha Yojana, the landmark health service scheme initiated by the Government of Sikkim is set to roll out from the 1st of October, 2021. Regular Government employees of the State including various PSUs and central government establishments on deputation who have enrolled for the scheme can avail of the services. This was informed by the Secretary, Chief Minister's Office, Mr. S.D. Dhakal in a press conference held at Tashiling Secretariat, today. The press conference also had the presence and participation of DG-cum-Secretary, Health, Dr. Pempa T. Bhutia, Secretary, Department of Personnel, Mr. K.C. Lepcha, and Special Secretary (DOP) Mr. Tashi Chopel.

Mr. Dhakal informed that a total of 56,280 beneficiaries have been enrolled under the scheme till date, which includes 21062 primary memberships. Highlighting the details of the benefits of the scheme and the eligibility criteria, the Secretary stressed that the Su-Swastha Yojana has been devised by the State Government after a series of consultations with concerned stakeholders to derive the best possible health care support for the state government employees. He added that the Scheme is offered at the lowest premium and highest coverage, with cashless treatment in over 400 reputed hospitals across the country. He explained that the implementation of the Scheme will be monitored by a Steering Committee headed by the Chief Secretary.

DG-cum-Secretary, Health, Dr. Pempa T. Bhutia informed that the scheme will cover the primary beneficiary and five other members of the family as per the criteria laid

down. He urged the beneficiaries to use the services judiciously. He said that beneficiaries can avail of the cashless treatment in reputed private hospitals, while the reimbursement facility can be availed of in case of mission hospitals, semi-government and government hospitals and the Government employees who have not enrolled on the scheme will not be entitled for the reimbursement facility.

Su-Swastha Yojana is a cashless health plan that covers 400+ top tier hospitals for all routine and critical illnesses for 1+5 dependents to the employees of the Government of Sikkim. It offers Cashless Inpatient (IPD) medical treatment of up to 10 lakhs and up to 20 lakhs for critical illnesses which is the highest coverage in India. In-Patient treatment covers hospitalization expenses for all admissions related to medical and surgical treatments for a large number of illnesses. There is no referral procedure. An employee can avail treatment from the hospital of his/her choice from a list of empanelled hospitals. There is no waiting period for coverage. Pre-existing diseases of the beneficiaries are also covered from day one for an enrolled member. It provides healthcare security to employees and their dependents. An employee can add up to five family members (1+5) as dependents to avail of benefits under this scheme. Parents (Mother/Father) and Parents-in-law (mother-in-law/father-in-law) of applicants can be up to 100 years of age. Age limit for unmarried & unemployed sibling brother/sister) is 30 years. The age limit for an unmarried & unemployed son is 30 years. There is no age limit for unmarried and unemployed

daughters.

Likewise, there is no age limit for dependent children and siblings with certified mental or physical disabilities. A beneficiary can choose from any of the leading hospitals in all major cities across India that are empanelled with Su Swastha Yojana. Option of mid-term addition and deletion of members is available (in the case of birth of a child, marriage, death of a member etc.) 24 X 7 helpdesk and call centre for hospitalization assistance is provided.

A Helpdesk is present in all hospitals for support and assistance. Members avail of post-hospitalization benefits of up to 30 days from the date of hospital discharge. This covers post-discharge expenses like medicine, follow-up treatments and tests. There is an emphasis on Women's health with Maternity benefits up to Rs 50,000/- for normal & caesarean delivery, and IVF (In-Vitro Fertility) treatment with coverage up to 2.0 lakhs. For a newborn child, health coverage of the child starts from day one of enrollment. This scheme also covers Daycare procedures such as Dental and Ophthalmic treatment (non-cosmetic), Dialysis, Radiotherapy, Chemotherapy for Cancer patients, Angiography, Endoscopic treatment etc. Vehicular accidents and Trauma are also covered. In case of an emergency hospital admission, for expenses not pre arranged as cashless, reimbursement will be issued.

Secretary Spices Board meets Chief Minister

Gangtok, September 07: Secretary Spices Board, Mr. D Sathiyam met Chief Minister Mr. Prem Singh Tamang to discuss the current production and export of spices and future prospects for large cardamom, today.

Secretary Spices Board outlined the projects and activities being implemented by the Board in the state starting with the Spices Park project at Namcheybong near Pakyong in East District under the Trade Infrastructure for Export Scheme (TIES) scheme. The total cost of the project is ₹26.51 crores and the Ministry of Commerce and Industry; Government of India has released ₹8.87 crores as the first installment to the Board. The Board signed an MoU with the Central Public Works Department (CPWD) for the construction of the spices park and the pre-construction activities have been commenced by the CPWD and the project is expected to be completed in 36 months.

It was also informed by the Secretary, Spices Board that an online auction for large cardamom would be introduced shortly in the state for ensuring better price realization to the farmers.

In regards to the exports, the

Secretary notified that 10 prospective entrepreneurs in Sikkim will be identified and registered as exporters for major spices like large cardamom, ginger, turmeric, cherry peppers (Dalle khorsani) and so on in the state and the entrepreneurs will be supported under the Board's export promotion schemes.

Apart from these projects and programmes, the Spices Board is implementing certified nursery programmes, replanting schemes, modified Bhatti scheme, and spice clinic for the benefit of large cardamom farmers in Sikkim.

Mr. Sathiyam complimented the Government of Sikkim for implementing the farmer incentive scheme for large cardamom (₹100/kg) and other spices for increasing the production of spices in the state. The Chief Minister appreciated the efforts of the Board and asked them to work closely with the Indian Council of Agricultural Research institute at Gangtok, Indian Agricultural Research Institute at Pusa, New Delhi and Sikkim University to address the fungal and viral diseases of large cardamom to increase the production in the state.

District Planning Committee Meeting of EDZP held

Gangtok, September 13: The District Planning Committee Meeting of the East District Zilla Panchayat (EDZP) was held today at the Zilla Panchayat Conference Hall, Sichey, today.

The meeting started with a power point presentation and an open discussion of various issues covering the State Finance Commission (SFC) Grant second Instalments 2020-2021, 15th State Finance Commission Tied and Untied Grant 2020-2021 second Instalment, Deen Dayal Puraskar fund utilization and Re-allocation Plans and Proposals.
