The Joint Secretary sensitized the participants about: The Rights of persons with Disabilities Act, 2016. Take measures for pre-natal, perinatal, post- natal care of mother and child, the appropriate government and the local authorities shall take necessary measures for the persons with disabilities, all the government institutions of higher education and other higher education institutions receiving aid from the government shall reserve not less than five percent seats for persons with benchmark

disabilities, every appropriate government shall appoint in every government establishment, not less than four percent of the total number of vacancies in the cadre strength in each group of post meant to be filled with persons with benchmark disabilities. He also highlighted infrastructure that the development should be there for all persons with disabilities in all government buildings and public places such as hospitals and commercial establishment.

of mental health patients at the level of community health subcentres. He also informed that as of now, 100% targets for appointment of trained personnel has been achieved in Sikkim and the focus has been solely on infrastructure development to fully implement the spirit of the Scheme by 2025.

He also spoke of the effects on mental health of school going children due to the shut downs of schools and the mental pressure on parents, especially mothers and the general effect on family life. He also spoke of how the Indian Psychiatric Association is looking into the post COVID period which could be a period of a mental health pandemic.

The Legal Aid Clinic was manned by Para Legal Volunteer, Ms. Sumitra Tamang who distributed pamphlets to the people relating to topics on general Legal Awareness and information regarding emergence contact numbers for women in distress and mechanism of Alternate Dispute Redressal Resolution. The Health Camp was manned by MO (I/C) Dr. Kanu Priya Rai and Ms. Hari Maya Tamang (FWA) who informed the public of the importance of regular medical check-ups, checked their blood pressures, prescribed medicines and gave them appropriate medical advice. There were around 43 people who visited the Legal Aid Clinic and 32 people who visited the Health Camp. They interacted with the representatives of the Departments present, to address their problems and to procure appropriate advice and guidance and thus benefited from today's

Gangtok, October 06: The fifteen days residential CHO Induction Training for the Mid Level Health Providers from the East and South districts of Health and Family Welfare Department concluded at SICUN Assam Linzey, today.

The closing day function was chaired by PDHS-cum-MD NHM Dr T. Yamphel Bhutia as chief guest along with DHS-cum-SLO Dr T. Doma, DHS-cum-SNO NHM Dr Raj Prabha Moktan and senior doctors and officials from Quality Assurance, Food and Drugs, NPCDCS, Human Resource, IT, IEC and Programme Management unit of the department.

As part of Ayushman Bharat, Community Health Officers are a new cadre of non-physician health workers. They are appointed with a vision to improve access to

healthcare in the rural and remote areas for the marginalized and vulnerable families, reduce out of pocket expenditure, increase utilization of public health services at the primary care level and reduce work load at the secondary and tertiary care facilities. CHOs will play a critical role in provision of expanded range of essential package of services as part of Comprehensive Primary Health Care. They are expected to lead the primary care team at the Sub Centre – Health and Wellness Centre, provide clinical management and ambulatory care to the community and serve as an important coordination link to ensure the continuum of care. The CHOs in Sikkim are all from the nursing background with most of them with BSc Nursing degree. All the sub-centres in Sikkim are provided with an MLHP

There were trained and certified resource persons for the Induction Training from the department. Gangtok, October 07: The Social Justice and Welfare Department organised an "Orientation Programme on 21 types of Disabilities, Evaluation and Procedure for Certification of Various Disabilities" at District Hospital Singtam, today.

Joint Secretary-cum-Nodal Officer for Persons with Disabilities, Social Welfare Division, Mr. Abinash Rai, Joint Commissioner for Persons with Disabilities (Technical), Office of the Commissioner for Persons with Disabilities Dr M.B. Chettri, Unique Disability Identity (UDID) State Coordinator Mr. Sameer Pradhan, were the representatives for the programme from the Social Justice and Welfare Department.

The participants for the programme included the Chief Medical Officer (CMO), District Medical Superintendent (DMS), ENT Specialist, Sr. ENT Specialist, Medical Specialist (Ortho), Physiotherapist, Pediatrician, Gynecologist, Medical Officers from PHCs, Dental Surgeons, Dental Consultant and Assistant Nursing Superintendents.

Joint Secretary in his address briefed about "The Rights of Persons with Disabilities (RPwD) ACT ", 2016 and spoke about the inclusion of 21 types of disabilities in the ACT and also highlighted the penalties one has to face if a person with disability is denied basic rights as mentioned in the RPwDACT 2016. He stated that a person with Benchmark Disabilities is the one who has forty per cent of the specified disability as certified by the certifying authority and also highlighted that no person having a disability less than forty per cent should be denied a disability certificate by the Medical Authority. He emphasized on the importance of being empathetic towards people with disabilities by the people and priority should be given by the hospitals regarding treatment of Persons with Disabilities and senior citizens.

Likewise, on October 04 a one day orientation programme for the same was held at the Conference Hall of District Hospital Gyalshing by Social Welfare Division, Social Justice and Welfare Department.

The Resource Persons for the programme were Joint Secretary-cum-Nodal Officer for Persons with Disabilities, Social Welfare Division, Mr. Abinash Rai, Joint Commissioner for Persons with Disabilities (Technical), Office of the Commissioner for Persons with Disabilities, Dr. M.B. Chettri and Unique Disability Identity (UDID), State Coordinator, Mr. Sameer Pradhan.

Addressing the gathering, Mr. Abinash Rai briefed on "The Rights of Persons with Disabilities (RPwD) ACT, 2016" and also highlighted the few challenges faced by the differently abled persons. He informed on the development of infrastructure for the Persons with Disabilities in the government offices, buildings and public places.

Dr. M.B. Chettri in his address list out all the 21 types of disabilities that have been identified under the RPwD Act 2016 of India to make people familiar with the help of Powerpoint presentation. The 21 types of disabilities are, Blindness, Low-vision, Leprosy Cured persons, Hearing Impairment, Locomotor Disability, Dwarfism, Intellectual Disability, Mental Illness, Autism Spectrum Disorder, Cerebral Palsy, Muscular Dystrophy, Chronic Neurological conditions, Specific Learning Disabilities, Multiple Sclerosis, Speech and disability, Language Thalassemia, Hemophilia, Sickle cell disease, Multiple Disabilities including deaf-blindness, Acid Attack victims and Parkinson's disease. The RPwD ACT 2016, Guidelines for Assessment of disabilities and Pamphlets on 21 types of disabilities were handed out to all the participants followed by a feedback session from the participants.

E-Daakhil portal launched

Gangtok, October 07: Minister for Urban Development Department and Food and Civil Supplies Department, Mr. Arun Upreti launched the E-Daakhil portal at NIC, Tashiling Secretariat, Gangtok, today.

It is to be noted that E-Daakhil portal is a Consumer Grievance Redressal portal, which has been developed under Consumer Protection Act 2019, which came into force in July 2020. It has a provision of e-filing of consumer complaints in the Consumer Commissions and online payment of fees for filing a complaint. This digital software for filing consumer complaints has many features like e-Notice, case document download link & VC hearing link, filing written response by opposite party, fling rejoinder by complainant and alerts via SMS/Email. The E-Daakhil portal empowers the consumer and their advocates to file the consumer complaints along with payment of requisite fees online from anywhere for the redressal of their complaints. It also facilitates the consumer commissions to scrutinize the complaints online to accept, reject or forward the complaint to the concerned commission for further processing.

The programme had the presence of Advisor IT Department, Mr. T. N. Lamtha, Secretary, Food & Civil Supplies Department, Mrs. Deepa Rani Thapa, DDG NIC New Delhi, Mr. D. C.
