The Quotations will be received through e-procurement portal [www.sikkimtender.gov.in](http://www.sikkimtender.gov.in) from 16:00 hours. on 20<sup>th</sup> December 2021 up to 11:00 hours on 20<sup>th</sup> January 2022. Any quotation or modifications to quotation received outside e-procurement system will not be considered. The electronic bidding system would not allow late submission of quotations. The Quotations will be opened online on 20<sup>th</sup> January 2022 at 11:30 hours; this can also be viewed by the bidders online.
5. If the purchaser's office happens to be closed on the date of opening of the Quotations as specified, the Quotations will be opened on the next working day at the same time.
6. The bidders need to submit in web-site furnishing with scan copies of valid Contractor/Firm Registration Certificate, GST Registration Certificate, PAN Card, No Relation Certificate, credentials establishing minimum eligibility criteria etc and Affidavit about the authenticity of document otherwise his/her quotation shall be declared as non-responsive & thus liable for rejection.
