1. This Invitation For Bid follows the General Procurement Notice for this Project that appeared in Development Business on 21/09/2016
2. The Government of India has received financing from the World Bank towards the cost of National Hydrology project and it is intended that part of the proceeds will be applied to eligible payments under the contract¹ for which this invitation for Bids is issued.
3. The Superintending Engineer, State Project Monitoring Unit, Water Resources and River Development Department, Govt. of Sikkim invites online bids from eligible bidders for “SUPPLY AND INSTALLATION OF ACOUSTIC DOPPLER CURRENT PROFILER (ADCP) AND DEVELOPMENT OF RATING CURVE FOR IDENTIFIED G-D SITES IN SIKKIM UNDER NATIONAL HYDROLOGY PROJECT”.
4. Bidding will be conducted through the National Competitive Bidding (NCB) procedures agreed with World Bank. The bidding is open to all eligible bidders as defined in the Bank’s Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 of the Guidelines setting forth the World Bank’s policy on conflict of interest.
5. Bidding documents are available online on <http://sikkimtender.gov.in> for a non-refundable fee as indicated below, in the form of Demand Draft/Banker’s cheque on any Scheduled/Nationalized bank payable at Gangtok in favour of **Superintending Engineer, National Hydrology Project**, Water Resources and River Development Department, Govt. of Sikkim. Demand Draft to be submitted subsequently as per the procedure described in paragraph 7 below). Bidders will be required to register in the website, which is free of cost. The bidder would be responsible for ensuring that any addenda available on the website is also downloaded and incorporated.

For submission of the bids, the bidder is required to have Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities, authorized by Government of India for issuing DSC.

Bids security of the amount specified in the bidding document, drawn in favour of “Superintending Engineer, **State Project Monitoring Unit, National Hydrology Project**, Water Resources and River Development Department, Govt. of Sikkim” must be submitted as per the procedure described in paragraph 7 below. The Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid. Bids must be submitted online on <http://sikkimtender.gov.in> on or before the date and time for receipt of bids, and will be opened online on the specified time and date for opening of bids, as given above. Any bid or modifications to bid (including discount) received outside e- procurement system will not be considered. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time. The electronic bidding system would not allow any late sub- mission of bids.
7. The bidders are required to submit (a) original demand drafts towards the cost of bid document; (b) original bid security in approved form; and (c) original affidavit regarding correctness of information furnished with bid document, original affidavit regarding validity of rates for the period specified as above to the “Superintending Engineer, **State Project Monitoring Unit, National Hydrology Project**, Water Resources and River Development Department, Govt. of Sikkim, Sokeythang, East Sikkim, 737102” before the opening of the Bid given above, either by registered post/speed post/courier or by hand, failing which the bids will be declared non-responsive and will not be opened.
8. Other details can be seen in the bidding document. The Purchaser shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Purchaser shall not be liable for any information not received by the bidder.
