INVITATION FOR EXPRESSION OF INTEREST/TENDER

For and on behalf of the Governor, the Directorate of Sikkim State Lotteries, Finance Department, Government of Sikkim hereby invites Tenders/Bids from the eligible Proprietorship/Partnership Firms/Companies registered under the law for appointment as Marketing Agent(s)/Distributor(s) for sale of a total of 24 (twenty four) Online/Paper Lotteries per day.

The interested Companies/Firms may collect the Tender Document/Application Form from the Office of the Director, Sikkim State Lotteries, Government of Sikkim, Gangtok as given below:-

1. The tender document containing the prescribed application form and detailed terms and conditions of the tender shall be issued only to the Registered Proprietorship/Partnership Firms/Companies/Firms registered under the Law on production of proof thereof.
2. The tenderer should be a bonafide Marketing Agent/ Distributor/Bulk Agent of sound financial standing having sufficient experience of at least 05 (five) years in the lottery business.
3. The tenderer shall have carried out similar jobs (i.e. sale/marketing of Online/Paper Lotteries) continuously for 02 (two) years in the last 05 (five) years and should have marketing of Online/Paper Lotteries atleast in 01 (one) State.
4. The tender document may be obtained from the Office of the Director, Sikkim State Lotteries, Government of Sikkim, Gangtok during office hours w.e.f. **26/04/2021** on payment of a non-refundable amount of ₹ 2,00,000/- (two lakhs) only as application fee by demand draft to be drawn on any Scheduled/Nationalized bank having its branch in Gangtok in favour of the Director, Sikkim State Lotteries, Government of Sikkim, Gangtok. However, the tender document shall not be issued after **12:00 Noon on 17/05/2021**.
5. The prescribed application form duly filled, along with all the requisite documents/certificates shall be submitted in sealed cover(s) to the undersigned during office hours on or before **12:00 Noon on 17/05/2021**. The applications received after 12:00 Noon on 17/05/2021 shall not be entertained.
6. The sealed tender documents received shall be opened by the Tender Selection Committee from 1:00 pm onwards on 19/05/2021 in the presence of the bidders or their representatives who may wish to be present.
7. The tenure of the contract shall be for a period of 05 (five) years from the date of commencement of the 1st (first) draw.
8. The 24 (twenty four) draws per day shall be divided into PART 'A' & PART 'B'. Each part shall contain 12(twelve) draws per day and 03(three) Bumper lotteries in a calendar year. Both PART 'A' & PART 'B' needs to be bid for separately.
